

**ANNUAL FORESTILLE YOUTH PARK BBQ**

**VENDOR REGISTRATION AND APPLICATION**

Fees: Single space: \$125 for one day or \$160 for both. Double space: \$175 for one day or \$225 for both. All fees must be paid in advance to reserve space. Applications received after May 15<sup>th</sup> will incur an additional \$50 late fee. Fees may be paid by check (see details below) or via the donation link at [www.ForestvilleYouthPark.org/donate](http://www.ForestvilleYouthPark.org/donate). If paid online, a screenshot of the confirmation must be provided along with your completed application.

Set-up: Booth set up must be complete no later than 10:00am Saturday morning. You may begin setting up as early as 7:00am Saturday morning. The vendor coordinator will be on site Friday, June 5<sup>th</sup> between 3:00-5:00pm for site assignments and to allow vendors to begin tent and table set ups. **Vendors may not begin setting up until they receive their site assignment from the vendor coordinator.** Vendors are responsible for providing their own tent/canopy, table, chairs, etc.

Utilities: Electrical outlets are NOT available. WiFi is NOT available and service in Forestville can be difficult, be prepared to accept cash.

Hours: Booths must remain open until 5pm. You may stay open later if you wish.

Site: Site sizes are approximately 10' x 10' for a single space, 20' x 10' for a double space.

## VENDOR RULES AND REGULATIONS

**Dates:** June 6<sup>th</sup> and 7<sup>th</sup>, 2026

**Hours:** 10:30 a.m. to 7:00 p.m.

### **REGULATIONS:**

1. The Vendor Coordinator will be available for site assignments and booth set-up on Friday, June 5<sup>th</sup> between 3:00-5:00. Vendors MUST check in for their site assignments.
2. Booths must be set up by and remain operational between the hours of 10:00 a.m. – 5:00 p.m. Your booth may remain open later if you choose to do so. Tents/Canopies, Tables, and chairs may remain in place on Saturday if you plan to attend both days.
3. Electricity is NOT available.
4. Vendors must provide their own booth and/or tables, chairs, canopies/tents.
5. Vendors are responsible for securing their booths and merchandise. Park security will not be responsible for Vendor's booth or its contents.
6. Vendors must possess insurance, at minimum General Liability Insurance.
7. All canopy/tenting must be secured with a minimum of 40lbs weights (10lbs per canopy/tent leg).
8. Vendors must keep their space properly clean and arranged. Vendors are responsible for their own clean-up.
9. Sound devices of any type are subject to approval of the Youth Park Directors.
10. The Forestville Youth Park Board of Directors reserves the right to prohibit any exhibit/concession or part thereof which may distract from or conflict with the character of the event or may be objectionable or offensive to neighboring stands or the public. This extends without limitations to persons, products, signage, or conduct.
11. **No dogs** are allowed on Youth Park property at any time, except for service animals.
12. By registering for and submitting a signed application, Vendors hereby acknowledge that they assume all risk and liability for all injury or damage of any kind to their property, product, or reputation and shall indemnify and hold harmless the Forestville Youth Park, it's agents and board members from and against all loss, claims for damages or expenses (including cost and attorney fees), arising in any manner out of the presence, activity, food, crafts, or equipment.
